



# 5 Reasons to Invest in Copper Miners

Copper has been essential for thousands of years and remains critical to fields ranging from construction to electronics. Now it's needed more than ever before, as increasing demand for electricity, the upgrading and expansion of power grids, and technological advancements such as artificial intelligence (AI) are underway. Also, the transition to clean energy accounts for 41% of the worldwide copper demand, a figure projected to soar to 68% by 2040.<sup>3</sup>



## Copper Demand Is Growing

Demand for electricity is estimated to increase 157% by 2050<sup>2</sup> as middle classes grow in the East, clean energy technologies proliferate, electric vehicles (EVs) gain market share and AI data centers provide a new demand shock for copper markets.

## Massive AI Data Center Power Requirements Are Copper Intensive

Globally, data centers' electricity demand may rise 2.5x by 2030, to a level approximating Japan's total power use.<sup>4</sup> As data centers' AI capabilities grow, so does the need for copper-intensive electrical equipment. Cumulative new copper demand from AI data centers is projected at 5 million metric tons by 2030. On an annual basis, this is equivalent to 2.8% of 2030's forecasted global demand. Further, BHP Group, the world's largest mining company, estimates that the copper used in data centers globally will grow six-fold by 2050, to around 3 million metric tons annually.<sup>5</sup>

*If global copper consumption is a cake, AI-driven digital demand is the frosting. Electrification and urbanization remain fundamental drivers, but AI and data centers introduce an entirely new layer of growth.*

## Copper Is Critical to the Future of Energy

Copper is required for energy transmission and infrastructure development. New energy grids are being created with urbanization and growing middle classes, and existing infrastructure is in need of ongoing expansion and upgrades that are often substantive. In addition, current and developing technologies, as well as clean energy sources, are heavily copper dependent.



## Copper Supply Faces Challenges

The global copper supply faces significant hurdles, as ore grades are decreasing in quality and copper reserves are shrinking. In addition, there are long lead times to develop new mines, where the average copper mine takes 17 years to move from discovery to first production.

The copper supply and demand imbalance may be likely to grow, and this underscores the critical role of copper mining companies in meeting demand.

### Copper Supply and Demand Imbalance May Be Likely to Grow





## Copper Miners May Benefit as Long-Term Energy Requirements Evolve

Copper miners may offer a long-term investment opportunity as global demand for electricity grows. The widening gap between supply and demand could translate into benefits for both copper prices and the mining companies involved. Additionally, long production lead times are causing larger miners to look to acquisitions, and an uptick in mergers and acquisitions (M&A) within the industry could further strengthen the position of copper miners.
