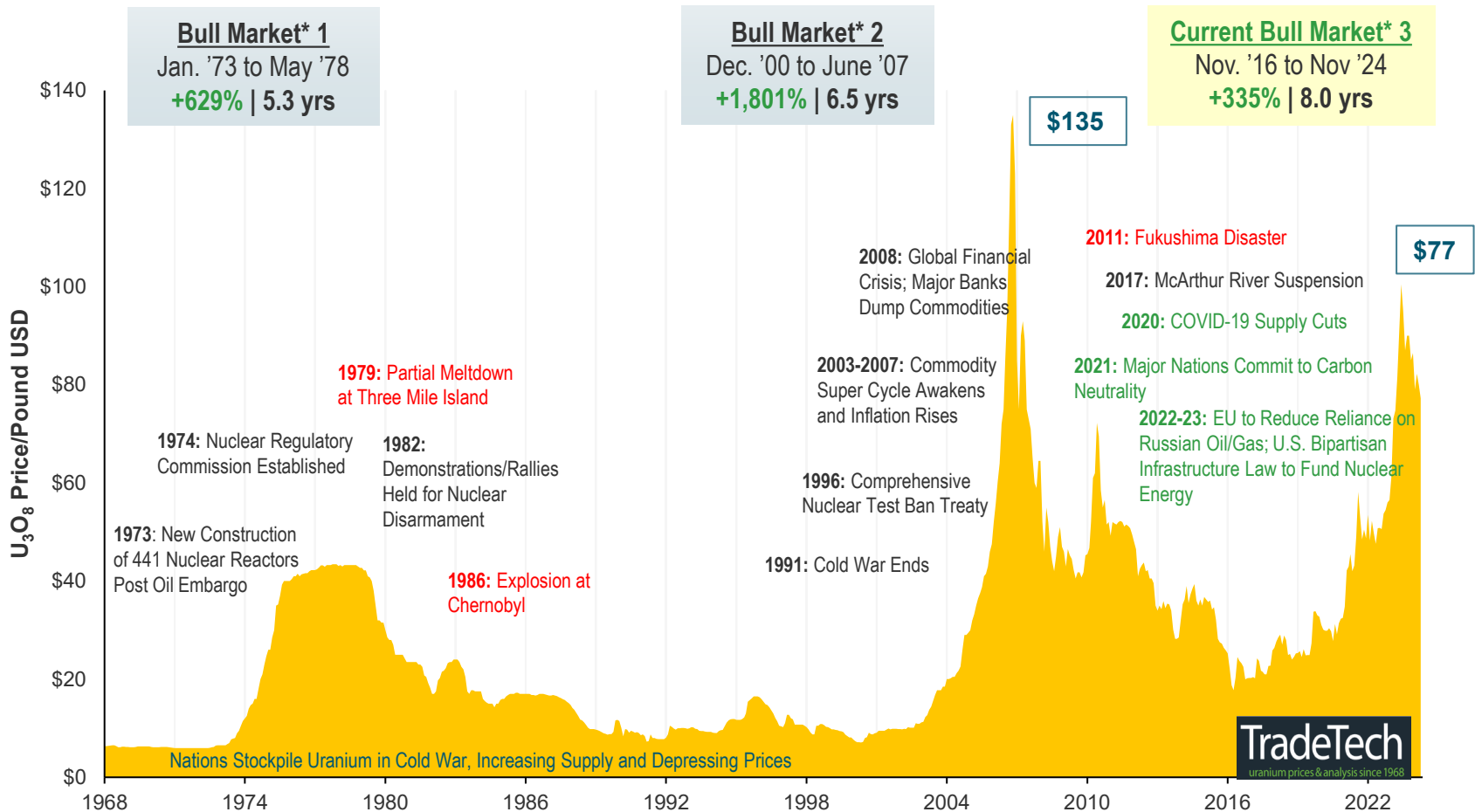


New Uranium Bull Market is Underway Potentially with Room to Run
